2nd Webinar on Life Insurance

The Institute of Actuaries of India (IAI) is pleased to announce a second Webinar hosted by the Advisory Group on Life Insurance.

The Webinar will focus on two themes, as outlined below:

1. Evaluating our response to the pandemic:

This presentation will have no dreary statistics on COVID 19, no insights from how the new infections tracked over the recent past in the various countries, no discussions on existing or new modelling approaches, and more importantly, no prophecies on the prognosis of this pandemic.

Instead, this presentation will look at the forced metamorphosis of life and health insurers, and at the possible implications of insurers', regulators' and governments' response to this crisis.

Is it too much to expect a sense of calmness in the current chaos? Is it too irrational to expect rationality in an unprecedented crisis? Is it too premature to list down lessons learnt from the way we have responded to this crisis so far?

2. Medical update on Covid-19 and impact on Life insurers' risk management

The session will cover a medical view on what the virus is, how it compares with other viruses - virulence, clinical signs and symptoms, potential treatments and complications with its impact on mortality and morbidity.

The session will also discuss changes in consumer behaviour and the related challenges in Life insurance with regards to on boarding and claims management and how these may be tackled.
