Annexure 1

Process document for Attendees to get CPD for Webinars

1. In order to get CPD for APS 9 purpose, following would apply
 - a. 75 % of attendance should be necessary during each session/ webinar. The delegate need to log in through their own Zoom ID only for getting the required CPD. For e.g. a session of 90 minutes - 70 minutes presence, and for 120 minutes session- 90 mins presence should be there.
 - b. At least 80% Multiple Choice Questions (MCQ) asked during the webinars need to be attempted invariably whether it is right or wrong. MCQ's will be asked in the form of polling during the webinar.
2. Video of webinar-
 - a. For the registered members, the Webinar video access will be available in the IAI member login for the period of 2 weeks after the event irrespective of their attendance.
 - b. Those who were unable to attend the webinar due to technical or other difficulties, need to watch the videos and answer the questions available in their login within 2 weeks of the webinar to gain CPD credit.
