Webinar on AYUSHMAN BHARAT health insurance scheme

The IAI is pleased to announce a webinar hosted by the Advisory Group on Sustainable Development & Microinsurance.

Ayushman Bharat, a flagship scheme of Government of India, was launched as recommended by the National Health Policy 2017, to achieve the vision of Universal Health Coverage (UHC). Today, Ayushman Bharat is the world's largest health insurance scheme covering 50 crore members with the budget of INR 6400 crores for the year 2020. This initiative has been designed to meet Sustainable Development Goals (SDGs) and its underlining commitment, which is to "leave no one behind."

With almost 3 years completed since launch, there is now adequate data available for the actuarial profession to look at the exposure, claims experience etc. This is a great opportunity for actuaries to showcase their expertise on such large diverse sets of data and explore the development of a framework for pricing, monitoring and analysis of experience. This product is also a huge opportunity for insurers towards bridging the protection gap. Another important aspect to consider is the likely impact of Covid-19 on the scheme experience. This webinar is an attempt to deliberate on these issues and explore approaches that may be useful for actuaries to adopt when working on such large health schemes.
