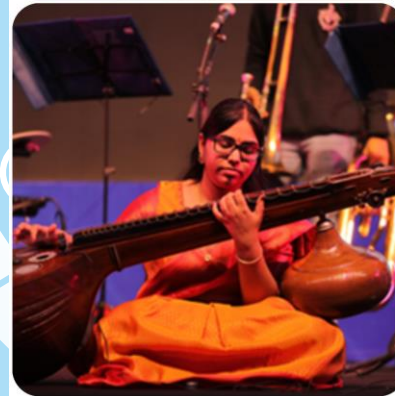

## GENRES

The bidders can choose ANY TWO of the below:

  - Indian
  - Other than Indian
- **Dance sequences**
  - Indian
  - Other than Indian
- **Standup Comedy / Humour**

## PERIOD

The Franchises should bid for three years.

The shortlisted franchise will receive a 15-minutes slot on either day 0 or day 1 evening.

## TEAM

The franchise should comprise of five or more IAI members with at least one IAI fellow.

## FRANCHISE BRANDING

This can include team name, a catch phrase, theme/genre, logo. The brand created will remain for three years.

## FINANCIAL SUPPORT

Each successful PF will receive up to Rs. 100,000 to defray the program cost for the 23<sup>rd</sup> GCA.

# Evaluation criteria for the bid



## Innovation score

- Innovation
- Name
- Novelty
- Branding
- Proposed theme/genre
- Objectives

15%



## Diversity score

- Diversity of team composition,
- Spread across COP holders, fellows, associates, students, insurance practices like life, non-life, pension, health and across organisations

25%



## Participation score

- Overall level and capacity of participation from each of the team members for the planned performance

30%



## Quality score

- Credentials of the performers - Records / Audios / Videos of past public performances, media exposures, any certifications

30%



Top 2 bids will be chosen by the 2024 GCA organising group using an independent voting system

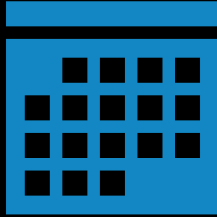
