Notice: Annual Membership Fees for the Financial Year 2026-27

This is to inform all members about the Annual Membership Fees applicable for the financial year 2026-27. Members are requested to carefully review the fee structure, payment modes, and timelines detailed below.

A) Applicability

The Annual Membership Fees for the financial year 2026-27 is payable by all members in accordance with their respective categories.

B) Annual Membership Fees: (Rates effective from 1st April 2019)

Class of Membership	Fees in Indian Rupees (₹)
Fellows and Affiliates	₹9,000 + 18% GST = ₹10,620
Associates	₹3,000 + 18% GST = ₹3,540
Students	₹2,000
Fellows, Affiliates and Associates above 60 years of age as on 1 st April 2026, and not gainfully employed in profession or practice or medically unfit to be gainfully employed in profession or practice	₹2,000 + 18% GST = ₹2,360
Life Membership (optional) for members above 60 years as on 1 st April 2026	Ten times the normal Annual Membership fee as mentioned above
Members above 75 years of age as on 1 st April 2026	No Annual Membership Fee
Change of Category within an Annual Membership year	Full Annual Membership fee for the new category will be applicable

C) Due Date

The Annual Membership Fee must be paid on or before 1st April 2026.

D) Failure to Make Payment

Failure to make payment by 1st April 2026 will result in expiry of membership and removal of the member's name from the Institute's Register.

Where Annual Membership fee is in arrears for more than one year, reinstatement will be made on payment of Annual membership fees amounting to the year in which the membership was lapsed and the current year Annual membership fees.

Additional Notes:

- **For Fellows, Affiliates, and Associates:**

Members whose Annual Membership fee is outstanding after 1st April, 2026 can apply for re-entry their names in the register of members by providing the reason for delay in payment of Annual Membership at the time of payment All such applications are subject to approval of the concerned authorities.

- **For Students:**

Members whose Annual Membership fee is outstanding for more than ten years can do reinstatement of membership offline only.
